

Photography and Filming Policy

Middlesex Cricket promotes the appropriate use of photography and filming of children and young people participating in cricket, however, it's important to be aware of the potential child protection and safeguarding issues that arise when people take photos or film children and young people in relation to sporting activities. The potential for misuse of images can be reduced if we are all aware of the potential risks and dangers and put appropriate measures in place to reduce these risks.

Potential Risks:

- Children and young people may be identifiable when a photograph or film is shared with personal information
- direct and indirect risks to children and young people when photographs or film are shared on websites and in publications with personal information that may identify and locate the child or young person
- inappropriate photographs or recorded images of children and young people
- inappropriate use, adaptation or copying of images

The following guiding principles from the ECB Photography, Filming and Social media broadcast Guidelines will be implemented by Middlesex Cricket:

- Photographs/images are not to be taken at matches or training without the prior permission of the parents, guardians/carers of the child. This permission can be given by proxy by the coach of each team only after parental consent for this has been granted. The coach will arrange this prior to attending matches or events.
- If no consent has been given for a child or young person on the player registration & consent form, then it is to be made known to the relevant person of the other team (e.g., coach / team manager) so that the appropriate person/s taking photos for the other team is aware and can avoid taking photos of that particular child or young person.

- The children and young people should be informed that a person will be taking photographs and how they will be used.
- The children and young people should be informed that if they have concerns, they can report these to the Coach or Team Manager.
- Concerns regarding inappropriate or intrusive photography should be reported to the County Safeguarding
 Officer- safeguarding@middlesexccc.com and recorded appropriately.
- It is recommended that at cricket tournaments/festivals/events/competitions that organisers set up a camera registration book for adults to complete.

The following guiding principles will be adopted for the publishing of images:

- Ask for parental, guardian/carer permission to use their child or young person's image and wherever possible show the image to the parents, guardians/carers and child or young person in advance. This ensures that they are aware of the way the image will be used to represent cricket and Middlesex Cricket.
- Ask for the child or young person' permission to use their image. This ensures that they are aware of the way the image will be used to represent cricket and Middlesex Cricket.
- If the player is named, avoid using their photograph or image.
- If the photograph is used, avoid naming the child or young person.
- Don't use player profiles with pictures and detailed personal information on websites.
- Don't use an image for something other than that what it was initially intended and agreed.
- Don't allow images to be recorded in changing rooms, showers or toilets. This includes the use of mobile phones and other devices that record images.
- Focus on the activity rather than the individual.
- Only use images of children and young people in appropriate kit (training or competition) to reduce the risk of inappropriate use, and to provide positive images of the children and young people.

- Aim to take pictures which represent the broad range of young people participating safely in cricket e.g., boys and girls, people with a disability, diverse communities.
- Encourage the reporting of inappropriate use of images of children and young people to the County Safeguarding Officer

Using video as a coaching aid:

Middlesex Cricket may use video equipment as a coaching aid, players and parents, guardians/carers may view the footage and know that the material taken in connection with coaching will be stored securely and will be deleted / destroyed upon requests, or when the material is no longer needed.

All players and their parents, guardians/carers will be asked to complete, sign and return a photography and filming consent form before engaging in Middlesex Cricket activities.
